Over 140 dormant VET providers no longer in the sector

The Australian Government is cracking down on dormant vocational education and training (VET) providers not actively providing training or assessment.

More than 140 registered training providers (RTOs) have had their registration lapse after not delivering training for 12 months or more.

The move follows new powers that came into force under the National Vocational Education and Training Regulator Amendment (Strengthening Quality and Integrity in VET No. 1) Act 2024 (the Amendent Act), passed by Parliament earlier this year.

The Australian Skills Quality Authority (ASQA) is closely monitoring another 140 RTOs that have been granted an extension up to 31 December 2024 to resume quality training or face their registration lapsing.

From 1 July 2024, an RTO that has not delivered training or assessment for 12 consecutive months must apply to ASQA for an extension of the measurement period¹ to operate.

ASQA may grant an extension up to 12 months where the RTO is genuinely committed to providing training and assessment. No further extensions are available after that.

The Act seeks to better target unscrupulous and non-genuine providers, and increases penalties for various offences five-fold.

The Act builds on the Australian Government's broader campaign to boost integrity and quality in the VET sector.

The government has also strengthened the Fit and Proper Person Requirements for those owning and managing RTOs, and provided \$37.8 million for VET integrity initiatives.
