SENATE ORDER FOR ENTITY NON-PROCUREMENT CONTRACTS LISTING RELATING TO THE PERIOD 1 July 2023 to 30 June 2024

The reasons for such clauses include ordinary commercial prudence and/or the protection of: trade secrets; proprietary information; Commonwealth material; and personal information.
